

### **El Cajon Collaborative Council Meeting**

February 1<sup>st</sup>, 2011 Meeting Notes

<u>Meeting Purpose:</u> To engage service-delivery staff and community members in resource sharing, networking, and action to benefit the children, youth and families of the El Cajon Community.

#### I. Welcoming Remarks & Collaborative Updates

Pam Toohey, Council Facilitator was unable to attend the meeting so Lea Bush, Collaborative Coordinator welcomed everyone and made announcements about upcoming events in El Cajon.

# II. Presentation: Income Tax Preparation and Assistance with Federal Tax Disputes for Low Income Individuals

Shahin Rahimi of Legal Aid Society of San Diego gave a brief overview of income tax preparation resources for low-income individuals in San Diego. Since there are many free resources available, Shahin recommends that individuals who qualify for free services avoid paying a tax preparer as it will help them save money.

Christine Ellingsen of the USD Legal Clinics shared a Power Point which covered their free legal tax clinic services and an example of a successful mediation between their student lawyers and the IRS. Shahin then shared more detailed information about how and why someone should utilize tax mediation with the IRS instead of "not opening the envelope".

Federal tax disputes for previous years can be handled by both Legal Aid and USD Legal Clinics, State tax disputes can be handled by the USD clinic. Current year tax preparation services are offered by Home Start for free by appointment. Lara Gamble of Home Start shared briefly about their tax preparation service for families (with children) who make less than \$48,500 a year.
