I. Welcome & Sharing Positives

III. Strategic Plan Update- "Public Safety"

DISCUSSION: The Core Team concluded that working in collaboration with the Recreation Department to offer services at their site could be an effective and efficient way of reaching youth and their families.

Key items:

- Reviewed El Cajon Survey response submitted by Lori (Park and Recreation Department) interested in partnering with community groups
- Goal of engaging youth, families and adults with affordable/accessible recreational opportunities that advance their overall health and wellness.
- Will be conducting surveys to identify gaps, assess interest, need, and engagement of more youth, families and the community at large participate into activities

Achieving Mutual Goals-

The Core Team concluded that working in partnership with the Parks and Recreation Department would be a way of achieving mutual goals. The focus of the Core Team priorities as per the direction of the Executive Team is to provide comprehensive services for youth using a public safety approach.

Potential How to implement (get started): lessons from Parks & Recs

- Using Park & Rec model- supports public safety by giving pro-social activities
- Differs from Boys & Girls/YMCA are membership driven
- Park & Rec- engages whole community vs. targeted neighborhoods
- Recognized need for organized sports to help deter gang activity
- Park & Rec
 - 7 sites & AYSO/Little League and school partnerships

ACTION:

- Next step: invite Lori to join the Core Team at the January meeting. Begin dialogue on how we might move forward.
- Discuss possibility of adding questions to Recreation's survey for additional community services that could be offered at a Recreation site.

 - As the workgroup identified its priorities, while the assumption was that additional classes are needed, the group concluded that the current classes are not all at capacity. There has been a substantial increase in ESL classes over the year. The group recognized that the focus should be on meeting class capacity. Some challenges include- consistent attendance, understanding of the requirements, student accountability and responsibility. Understanding these barriers and identifying solutions has become more of a focus. The risk is that classes could close due to insufficient attendance and gains would be lost. The concrete action is the development of a list of locations in El Cajon where ESL classes are offered along with contact information.
