



**El Cajon Collaborative  
Core Team Meeting Notes  
August 17<sup>th</sup>, 2010**

**I. Welcome & Sharing Positives**

Rosa Ana Lozada, Core Team Chair opened the meeting with introductions and sharing of positive information from the group.

**II. Approval of July Meeting Notes**

The July meeting minutes were unanimously approved.

**III. Discussion on community needs assessment/strategic planning**

DISCUSSION:

- Lack of traction on Strategic Planning
- Sub-group led by Joe Eberstein, Jeneé Littrell and Suzie Moser recommended gathering 3 goals/priorities for involvement in El Cajon Collaborative from each organization.
- Barbara Ryan noted we should keep in mind difference between Providers' and communities' needs.
- We can construct alternate surveys or data collections to include more community feedback – this would only be a “place to start”.

ACTION: Lea will follow up with email to Core Team, will prioritize for continued discussion at Executive Team in October.

CONSENSUS DECISION:

- Lea to send something out to gather 3 priority areas of each organization. Also ask - what would you like to do but can't?

**IV. Coordinator's Maternity Leave Plan**

The Coordinator's maternity leave plan was passed out and discussed. No changes or updates were made. She will be on leave starting October 1<sup>st</sup>, 2010 and will return part-time on January 3<sup>rd</sup>, 2011 and then full-time February 1, 2011.

**V. Updates from the Coordinator**

- The SANDAG grant is being continued for another year. More details will be discussed at an orientation today, but final approval of the contract will likely be needed prior to the Coordinator going on leave in October. Rosa Ana Lozada requested information on the data that has been collected by the Collaborative. Lea noted a report is being developed and can be distributed at next months meeting.
- Parent Forum on Vaccinations is planned for September 22<sup>nd</sup> at the El Cajon Library, a flier with information will be sent soon.

- Joe Eberstein of IPS noted that their contract for binge/underage drinking, methamphetamine prevention and marijuana prevention is still awaiting final decision by the County.
