III. Collaborative Business A. February Finance Report- Barbara shared the February Finance Report with the group. There was a discussion about the deficit and Dana recommended that the deficit total at the bottom of the ECC Comparison Budget be taken out of LH Avocado donation first, then Reserves rather than show a deficit amount. One of the suggestions was from Karen regarding CVUSD's board member to create updated middle school sports fields. Youth leadership programs included STAAND, YALLA, Youth Police Academy, Salvation Army programs, Scouting, and RLAs. Ways that the Collaborative can assist are with promoting stakeholders through the website, information sharing and Facebook. Objective 3.3 Activity 2 should include FHCSD's new program to teach patients about healthcare access, picking a health plan and patient responsibilities and right. License to Freedom is working with their newcomers with programs to highlight when to use the emergency room and stories to help highlight wellness. Mohammed shared that NSD has a 4 hour program based on the book, "What to Do When Your Child is Sick." It incorporates the use of refugee doctors to give practical knowledge to parents. Thanks to everyone for their assistance.</p> <p>Molly- FHCSD will be holding the grand opening of their El Cajon clinic on either May 13th or 20th. She will send an invitation.</p> <p>Dana- CASA is conducting surveys with their public health interns in the lowest income areas of El Cajon using hand-held devices. The students are multi-lingual to address the needs of our community members.</p> <p>Dilkhwaz- License to Freedom held a Syrian Health Relationship workshop that reached over 200 newcomers. There was tabling on sexual violence resources. She is working with San Diego Women's Studies at SDSU for assistance with grant writing.</p> <p>Nicole- Home-Start now has an Arabic speaking CalFresh application assistor. Free tax services are continuing throughout tax season on Wed. through Sat. at Little House. Other locations are throughout the county. They also have a nutrition assistant who is conducting outreach.</p>
